Terms and conditions

“Leonardo 4 Music” Awards 2023

Climate, Equality & Peace

The “Leonardo 4 Music” Awards are part of the “Leonardo 4 Children” non-profit initiative. The Awards allow young music composers to use and develop their creativity and artistic skills to interpret with an original music key topics of global relevance: climate change and environmental sustainability, equality including gender and social equality, and peace.

The participants can take as source of inspiration a fable or a work by Leonardo da Vinci, an original work by winners of the previous editions of Leonardo 4 Children, the scene of a movie, or a poem/story on the topics of climate, equality or peace.

1. Duration

The award is open between **20th December 2022** and **31st May 2023**.

2. Eligibility

“Participants”: the authors of the works eligible for the awards shall be young people legally resident in a Member State of the European Union¹, UK, Switzerland, Norway, Iceland, Western Balkans, aged **between 16 and 30 years old** at the date of submission, enrolled in or graduated from a High school / Conservatory / Music school.

Contributions from young composers resident in other countries are welcome, and may receive a special mention by the Jury.

“Applicants”: the formal application to the award shall be submitted by adult participants (aged 18-30) or by the responsible adults of minor applicants (aged 16-17), for example teachers or parents, having the approval of the legal representatives of the participants to take part in the award and subscribe to these “Terms and conditions”.

3. Work

The young music composers are invited to use their creativity to invent an original music composition interpreting one or more of the topics “Climate”, “Equality”, “Peace”.

The work should:

- be completely **original** and not contain any third party's work;
- have a duration **between 3' and 10'**;
- consist of a **tonal music** using between **1 and 7 music instruments** (for example: piano, violin, viola, cello, bass, flute, oboe, clarinet, harp, guitar, percussion instruments, electronic instruments), and/or **songs by singer voices or choir**;
- be inspired and focused on the topics of **climate, equality and/or peace**, for example:
 - for the topic "**climate**", interpret the issue of climate change and environmental sustainability, such as: natural environment and biodiversity; water; recycling; energy; transport; agriculture and food;
 - for the topic "**equality**", interpret the issue of equality between people, such as: promoting non-discrimination and social inclusion, fighting social stereotypes; promoting gender equality, fighting gender stereotypes; promoting income equality, fighting poverty;
 - for the topic "**peace**", interpret the issue of peace between people, such as: peace among family members and friends; peace among social, political, ethnic, economic groups; peace among people, nations, regions.

The participants **could be inspired** by one of the following:

- Works by Leonardo da Vinci on nature or equality, such as selected fables by Leonardo da Vinci, available at <https://carano4children.org/fables-of-leonardo-da-vinci>;
- Fables by children or Art & Science works by teenagers which won the past "Leonardo 4 Children" editions, available at <https://carano4children.org/leonardo4children-2020>

- Scene of a **movie** or a **story** (e.g. poem, fable) which relates to climate, equality and/or peace.

4. Submission

The work should include:

- a **partition**, possibly written using a programme for musical partitions (eg Sibelius, Finale,...);
- the **text** played by the voices and choir, if applicable
- a **recording** of the composition or a MIDI file, if possible.

The works shall be submitted using the form available in Annex 1 and at: www.carano4children.org/leonardo4children-2023. The form, duly completed, must be sent to the following e-mail address: leonardo@carano4children.org.

By submitting the application, the participant agrees with these “Terms and conditions”.

The participants are welcome to post information on social media using @carano4children and #Leonardo4Children.

5. Scoring

The eligible works will be scored using the following award criteria:

- Inspiration on the selected topic of climate, equality and/or peace;
- Creativity and originality;
- Quality of tonal music;
- Quality of vocal and choral elements, if applicable;
- Alignment with Leonardo’s work or other source of inspiration (movie, story), if indicated by the applicant.

6. Jury

The Jury will be selected by the Advisory Board and include professional members from at least 3 different countries: composers, musicians and singers.

The Jury members shall be independent, have no conflict of interest and commit to adhere to the highest standards of impartiality and fairness in their judgement. During the evaluation process, the Jury will not have access to the personal data of the applicant, nor the participating children, in order to ensure fairness in their judgement.

The participants cannot contact the members of the Jury. The judgement of the Jury is final and cannot be appealed.

7. Awards

The announcement of winners will be made by **June 2023**, and the award ceremony will take place in **October 2023**.

The 1st winning composer will be offered the opportunity to use her/his music composition for a campaign or a promotional video of UNICEF Belgium.

The 2nd winning composer will be offered the opportunity to use her/his music composition for the promotional video and campaign of “Leonardo 4 Children” non-profit initiative.

The **3 works** with the best scoring will receive an award, which will consist in:

- **talent development programme**, with a budget of **€ 500** for the 1st winner and **€ 300** for the 2nd and 3rd winner, which can be used for developing the music skills of winners, for example via workshops, visits or material;

For the 2nd winner, the special **“Ermanno Testi” prize** of € 300 is dedicated to the memory of Ermanno Testi, who passed away on 15 October 2022. Musician, with a diploma in piano and jazz music and specialization in choral conducting, counterpoint and fugue, Ermanno Testi was a concert performer, teacher, musicologist and music critic. He dedicated an intense and passionate activity as choir director, performing in Italy, Europe and America and received prestigious national and international awards.

- **live performance of the winning music works** at award ceremony and concerts/events; **promotion** on website, social media and promotional material, at public events, institutions or public places;
- **publication** on “Leonardo 4 Children” book;
- **“Leonardo 4 Children” award certificate.**

The Jury may decide to provide other **special awards**, including proposing the winning works to take part in other famous music awards. We invite partners and sponsors to offer **special awards** for the winners to develop their talent in music, for instance in memory of music personalities and experts.

8. Compliance and license

By participating in this award and submitting any video, image, audio file or any other material related to this award (hereafter 'the works submitted for this award'), the applicant:

- ensures compliance of his/her submission with the applicable law;
- warrants that the works submitted for this award does not infringe the rights of any third party nor violate any applicable law or regulation;
- declares that he/she holds all the intellectual property rights covering the works submitted for this award, and/or that he/she obtained appropriate authorisation from the concerned right-holders to use their works in the works submitted for this award such as from the legal representatives of minors;
- grants the “Carano 4 Children” foundation a worldwide, royalty free, perpetual (for the

duration of the applicable copyright), non-exclusive licence to reproduce and communicate to the public the works submitted for this award and to distribute copies thereof. Under this licence, the “Carano 4 Children” foundation will in particular be entitled to use the works submitted for this award for publication on any form of media, including for products and services used for fund-raising in favour of the no-profit philanthropic and charity objectives of the “Leonardo 4 Children” initiative;

- for winners and for participants who will send the original works, grants the “Carano 4 Children” foundation the right to use the original works for exhibitions and for auctions to raise funds in favour of the beneficiary projects of the initiative, i.e. for the education in art & science of children in need.

The applicant should explicitly decide whether to authorise the “Carano 4 Children” foundation to use and publish the name and surname of the authors of the works submitted.

Specific proof of authorization of the legal representatives of children will be requested for the winning works.

The terms and conditions of this award are governed by Belgian law, and any disputes arising in connection with them shall be subject to the exclusive jurisdiction of the Belgian (French-speaking) courts.

9. Privacy policy and data protection notice

Overview

The initiative “Leonardo 4 Children” and related awards are managed the online website www.carano4children.org (“website”) respecting the privacy and the data protection of people involved. The intention is to provide a secure and safe environment for all users, with particular attention to children. The following statement outlines the policies by which the data provided by users, and how users of the website may exercise their rights, is collected, managed, and used.

The use of the website and participation in the awards indicates you have read these policies and agree to abide by them.

The data protection notice stemming from this privacy policy will be made available via the website to the data subjects (participants to the awards) in a separate document.

Information collection

To serve its users in the best way possible, the initiative requires users to submit the following information as a part of the application for the awards:

- Applicant’s data (adults): name, surname, email address, country and school or organization (if applicable).
- Participant’s data (6-12 years old children, 13-18 years old teenagers): name, surname, date of birth.
- Participant’s data (18-30 years old music composers): name, surname, date of birth, certificate of diploma or attendance to conservatory or music schools.
- Legal representatives of the minors: name, surname, email (for award winners only).

The applicant submitting the works agrees to act as Data Processor with respect to the “Leonardo 4 Children” awards.

The website is controlled by the “Carano 4 Children” no-profit foundation, established in Brussels, Belgium, which acts as the Data Controller for any personal data collected via the platform. Contact information for “Carano 4 Children” foundation can be found below.

Use of collected information

Personal information provided by the applicants or collected during usage of the platform will only be used to implement the awards including:

- publishing the names of the participants on website and media;
- for winners, awarding the prizes and publishing the works and name/surname on a multimedia product which will be used for no-profit purposes of the initiative;
- to provide information on the non-profit initiative “Leonardo 4 Children” via newsletters and emails, with the option for the receivers to ask removal from the distribution list.

Access to the data provided by the applicants is strictly limited to “Carano 4 Children” foundation.

The transfer of specific data to other third parties can be permitted under the specific authorisation of the “Carano 4 Children” foundation acting as the Data Controller; such authorisation will only be granted by the Data Controller to third parties with a legitimate interest in the award such as for benefiting of the awards or for publication purposes. Personal data will only be transferred in accordance with applicable regulations.

The “Carano 4 Children” foundation will not divulge any personal data for direct marketing purposes to third parties.

The “Carano 4 Children” foundation will have access to provided account information and can modify and/or delete information as needed to maintain the integrity of the user database or to ensure the proper operation of the platform.

Length of data storage

Personal data provided by the users of the website or collected during their usage of the platform will not be stored by the “Carano 4 Children” foundation in a form allowing the identification of the users for longer than five year after the date of the close of entries for awards, except for data related to the winners which will be made public.

Site security

The platform has implemented and continues to maintain appropriate technical and management measures to keep your personal information secure and safe from loss, damage, corruption, or deletion.

Data subject’s rights

The applicants are entitled to the following data subject’s rights: right of access, right to rectification, right to erasure, right to restriction of processing, right to data portability, right to object, in line with Regulation (EU) 2016/679 art. 15-21.
